THIS DOCUMENT SERVES AS AN AGREEMENT BETWEEN THE GYAA AND THE PARENTS OR GUARDIANS OF THE ABOVE NAMED CHILD SUBJECT TO THE FOLLOWING CONDITIONS BELOW: By signing below, I, as a parent of the above named child, who intends on participating in the GYAA Competitive Softball Program ("Program"), hereby consent and give the express approval of all the child's parents or guardians, to the child's participation in any and all of the activities of the Program during the season indicated above. I hereby state that I have such authority to consent and approve to the child's participation. I, along with the other parents or guardians (hereinafter referred to collectively and individually as "We"), assume all risks incidental to the conduct of all activities and transportation to such activities. We do further hereby release, absolve, indemnify, and hold harmless the GYAA or the Program (hereinafter collectively referred to as the "GYAA"), coaches, organizers, sponsors, supervisors, directors, the City of Germantown, and all or each of them, from any actions arising directly from, or reasonably related to the activities or the Program. In case of injury to the child name hereinabove, we waive all claims against the GYAA, organizers, sponsors, the City of Germantown, or any supervisors, coaches, directors, or leaders appointed to them. I will furnish a certified birth certificate for the above named child and understand that all new players to the Program must provide a birth certificate prior to any participation in the Program's activities. I understand that registration fee refunds may be subject to a \$20 processing fee and that significant other costs (uniform, tournaments) are not included. In the event any of our programs exceed the limit imposed upon us by the City of Germantown, Germantown residents will be given first priority. As signified by the mark of the undersigned parent or guardian of the above named child, we hereby give consent for all medical care prescribed by a duly licensed medical doctor, for the above named player, under and for whatever conditions are necessary, in the opinion of the said doctor, to preserve, the life, limb, or the well being of the child, as a consequence of participation in the GYAA. We authorize the officers, leaders, coaches, and directors of the GYAA, as well as agents thereof, to transport the above named child as required or needed to and from any GYAA sponsored activity. We understand that any insurance coverage that may or may not be part of the above named child's registration fee for participating in the GYAA is strictly SUPPLEMENTAL to our own coverage. We hereby also pledge and agree to abide by, be bound, and faithfully adhere to the constitution, rules, policy statements, by-laws (and any amendments thereto) of the GYAA, including any and all decisions or resolutions of any administrative, organizational, or executive board of the GYAA, specifically, I have read the GYAA issue management policy and the parents code of ethics available for download at the gyaa.org web site.
